1. Anyone can enter; all photos must be taken of Franklin County and Shippensburg.
2. Photos must be original work of the individual submitting the image.
3. Each submission **MUST** be a digital file and a print photo on photo-quality stock in 8"x10" or 8.5"x11". Each submission must have a completed entry form and release form to be eligible, and all digital files must contain the last name of the photographer.

5. Photos must be received no later than May 7th, 2021 to be eligible for the contest.
